Documentary details abuse by McCormack colleague

♦ Hand of God: Brother of victim says bishop protected abuser.

Years before the Boston priest sex scandal broke in 2002, former Massachusetts resident Paul at the Archdiocese of Boston and said he had been sexually abused in the 1960s by a nowdeceased priest, Father Joseph mack, who later became an Birmingham.

He was struggling with personal problems and wanted help to pay for counseling, said his brother, Joe Cultrera, whose film about his brother's abuse — "Hand of God" — was broadcast by WGBH last night on PBS's "Frontline." The 1½-hour show is scheduled to air again at 10 p.m. tomorrow on WENH.

At the time, the archdiocese was capping most payments at \$20,000 a victim, a paltry sum

compared to the millions it would pay out a decade later.

But the Cultreras had a little secret. If the information were exposed, it could derail the future of a promising priest, Joe Cultrera approached officials Cultrera said. Paul ended up with three times the normal settlement amount.

The priest: John B. McCorauxiliary bishop in Boston and, in 1998, the Bishop of Manchester.

The secret: McCormack, the Cultreras believe, was aware of Birmingham's abuse of boys and allowed him to be transferred to occurred again and again.

"It was our one leverage," Cultrera said in an interview vesterday. "It was a year later he was made (auxiliary) bishop."

In the past, McCormack has said he does not recall ever seeing Birmingham, a one-time seminary classmate, abuse any one. He has also said he's asked

to stop Birmingham.

"Hand of God" concentrates on the tight-knit Cultrera family members, who grew up in Salem, Mass., Birmingham's history of abuse and how the family handled revelations of the abuse.

Paul Cultrera said McCormack's handling of his case "is the one thing that stuck in my life and made me feel really bit-

The Cultrera children were schooled at St. James in Salem. Both Birmingham, who died in 1989, and McCormack were assigned to St. James at the time. In the film, Paul Cultrera reserves his criticism for church hierarchy.

"Being a bishop," he said, "means you are probably a rotten guy who has climbed to the top of the corporate ladder."
